- Ben also provided a brief overview of the TUFSS meeting that took place the previous day Nov. 22<sup>nd</sup> 2019
  - Multiple stakeholders were present at the meeting; ADs, ATs, NHIAA, Burke family and others were in attendance for presentations by KSI and discussion
  - Discussion surrounding policies and procedures within the state over several topics including EAPs, Rectal Temp and Heat related issues – changes are possible. Question at hand: does it need to be mandated at the state level? General need to be educating the general public and state legislature about athletic training and athletic trainers. Overall trying to advance safety policies that may need to come from above.
  - Conversation continued with stakeholders
  - NHATA Member input during this discussion about general push back from the NHIAA regarding mandating this type of thing and concern that if mandated by the NHIAA, the NHIAA may not be able to enforce due to lack of man power to make sure safety measures are being taken
  - Having mandates at the state level would mean that schools without athletic trainers would be held to the same standard as schools with athletic trainers
  - Member question: Have they (KSI) gone to other states for similar discussions? Yes, they are working on going to all 50 states over 5 years, NH was number 12
  - KSI is willing to return to facilitate another meeting and assist with policy writing
